Attending Classified Sessions

To attend classified sessions, you must be a U.S. citizen with, at a minimum, a SECRET U.S. Security Clearance with a need-to-know in the areas of rocket, missile, space, or gun propulsion. In order to be granted access to classified sessions, documentation must be submitted **no later than 17 November 2023** (NO exceptions) in addition to normal registration requirements/deadlines. By this date, DoE and NASA employees and ALL contractors must submit the completed Security Clearance Certification Form. DoD employees must submit the Visit Authorization Request (VAR) via DISS by this date. Additional information and links will be provided when registration opens in approximately late September.

JANNAF Portal Account Requirement

If you do not currently have a JANNAF Portal account, you are encouraged to apply for your JANNAF Portal account *as soon as possible* -- whether you have received attendance approval or not. The JANNAF Portal account is a registration pre-requisite; it is NOT meeting registration. Therefore, there is no reason to delay. Please review the information on the <u>Security/Attendance and Portal Account Requirement page</u> for further information, or contact a member of our security staff (contact information below).

Online Registration Form

This required form must be completed by ALL attendees; login to your JANNAF Portal account is required. There is no financial commitment with this form so you can complete the form if you're fairly certain you'll be attending.
