

JANNAF Policy on Papers

The “Publication Clearance Form for *JANNAF Journal* Manuscripts” must be submitted with the appropriate information and signature, indicating the approval of your government sponsor or program management to publish your paper.

Manuscripts submitted for publication in the *JANNAF Journal* must be accompanied by this official JANNAF Publication Clearance Form. Internal paper release forms from other organizations will not be accepted.

The form can be found on page 2.

Distribution Statement Usage in JANNAF

- Per DoD Directive 5230.24, distribution statements are meant for “secondary” distribution.
- By signing this JANNAF Publication Clearance Form, the releasing official is permitting the JHU-WSE Energetics Research Group, the JANNAF Support Contractor, to publish and disseminate this material in accordance with the distribution statement criteria outlined on this form.

Controlled Unclassified Information (CUI)

All printed and electronic, including digital, technical documents that are determined to contain Controlled Unclassified Information (CUI) data shall be marked.
